P71 Sports Club, Wharf Lane Recreation Ground.

Councillors considered a request from Ilminster Cricket Club for the Town Council to submit and pay for a planning application for work to the sports club. The plans were displayed 30mins prior to commencement of the meeting.

Issues discussed included:

- Little information on door widths & disabled toilets
- Manhole covers
- Exciting that these facilities will be redeveloped and improve sporting facilities for the town
- Question raised if the Council would pay and submit the application
- Agreed to approve in principal providing plans are fit for purpose prior to submitting to planning

P72 Ilminster Drains and Gullies.

The Assistant Highways Service Manager has provided the following information (10 December 2015) in response to an enquiry from the Town Council

"Drain cleaning will commence in the New Year which covers all of the Ilminster Area. Contractors are currently doing a round of 2400 gullies which covers Buckland St Mary, Horton, Donyatt, Combe St Nicholas and Ashill and this could take until the end of January to complete. Ilminster with 980 gullies will follow on immediately after this round".

Issues discussed during this consideration of this agenda item included:

- No flooding issues had been reported to the Town Council Office over the Christmas period
- Some grates blocked but these had been reported direct to relevant authorities
- Urge the public to report issues in order for a log to be maintained which could increase the cleaning in problem areas, if issues are not reported no improvements can be made
- Take photographs to support issues
- Rain has caused issues with infill around man hole covers, issues of more than 1 inch can be reported to highways.
