## 542. Declarations of Interest

All Councillors declared a personal interest in Agenda item 4: Independent Grievance, Capability and Disciplinary Panel - Review of Resolution and Sanction as members of the Town Council.

#### 543. Exclusion of Press and Public

# 544. Independent Grievance, Capability and Disciplinary Panel - Review of Resolution and Sanction

The Chairman reminded members of the proposal as detailed in the Agenda and advised that membership of South West Councils had been completed and she introduced Rachel Grandfield, Regional HR Adviser, who was attending the meeting to provide professional advice.

It was then proposed and seconded that the Appeal and Review Panel comprise of Councillors Belobaba, Dewick and James. On being put to the vote, this was carried (voting: 10 in favour, 1 against, 3 abstentions).

Councillors discussed a possible date for the Appeal Panel Meeting and it was agreed to hold it on Friday 4<sup>th</sup> January 2019 at 14.00hrs in the Council Chamber, Council Offices, North Street, Ilminster.

#### **RESOLVED**

- (ii) that the Appeal Panel be given delegated authority to conduct any proceedings and to take any decisions and actions, including the determination of sanctions, which it deems appropriate following receipt of the independent investigating officers report, letter of dismissal, letter of appointment of panel members and any other relevant documentation:
- (iii) that the Appeal Panel have access to independent HR advice.
