### 124. Planning Observations

The Committee were informed that a new Licensing Application had been submitted for the premises 10 Silver Street, The Ilminster Bookshop, Ilminster Somerset TA19 0DJ.

### 125. Parking

The Town Clerk reported to Committee that she had attended a meeting with representatives from the Town Council and Somerset County Council Highways, as well as Somerset's County Councillor and District Councillor to discuss various highways and parking issues in the town. The following issues were highlighted during the meeting:

- (i) The procedure for dealing with requests relating to new or changed on street parking arrangements is for them to be considered initially, by the Town Council, and any recommendations be sent formally to Somerset County Council.
- (ii) There are criteria to be met for residents parking to be considered. It was agreed that the Town Council would explore the idea; there is a substantial amount of information and research to be undertaken e.g. level of support, impact on traders the cost of permits
- (iii) The disabled parking provision in the town centre and if it could be improved
- (iv) The law for loading and unloading buses was clarified – specific bus stops are not required
- (v) The possibility of locating a temporary speed indicating device at Bay Hill, Ilminster was discussed.
- (vi) The infrastructure of culverts and drains in Ilminster for surface water dispersal was discussed – an additional kerb gully has been ordered for Ditton Street but the main problem is the age and condition of the pipework. It was agreed to investigate the possibility of obtaining S106 monies from future developments to replace the existing pipework.
- (vii) The surface water flooding by Trafalgar Court has been investigated and a potential cause found. Steps have been taken to try and remedy the problem.

(viii) “20s Plenty” is not a local initiative; it is where 20mph speed limits are set on residential roads. The 20mph limit is difficult to enforce and a blanket approach is not advisable.

Issues discussed by the Committee during consideration of this item included:

- Locations in the Town that would possibly most benefit from residents parking
- How to obtain a balanced picture of residents views
- The impact of new housing developments upon parking
- The location of existing disabled parking bays in the town
- Possible locations for disabled parking bays – Councillors Storey and Shearman to research existing provision and potential locations and report back to the Planning, Highways and Transport Committee.

**126. Burleaze Farm Cad Road, Ilton, Ilminster, Somerset TA19 9HF**

The Committee were informed of a pre-consultation taking place regarding a proposed upgrade to the existing site at Burleaze Farm Cad Road, Ilton, Ilminster, Somerset TA19 9HF. It was reported that the improvements to be made would provide new 3G/4G coverage in the area.
