161. Police Report

- 1 Speeding offence in Donyatt
- Anti social behaviour

- The Ilminster Police Officers are provisionally scheduled to move from the existing Police Station to offices in the Medical Centre at the beginning of February 2016.

- Cllr Keitch is a member of the District Council Democracy & Schools Working Party considering how to get young people more involved
- There is a Scrutiny Group for the Journey of Exploration which is considering whether SSDC can jointly work with another Somerset District Council
- Careline have funding from Devon and Somerset Fire and Rescue Service for smoke detectors – more information is given in the SSDC newsletter

Ilminster Literary Festival – Cllr J Fowler

The representative highlighted:

 The schedule is currently work in progress and it is hoped that the complete programme will be available in February; sponsorship is being sought for various events

Dementia Alliance - Cllr J Sothern

The representative highlighted:

- Unfortunately a copy and paste error had omitted thanks to Cllr Fowler for hosting a training event
- Ilminster is one of the top 10 areas for being pro-active
- Work with Tesco is on going regarding opening / designating a "slow lane" where additional time and help can be given to shoppers when paying and packing.

166. Letter from the Planning Inspectorate, Notice of Local Enquiry to Determine the Wildlife and Countryside Act 1981, Section 53, Somerset County Council, (No 1) Modification Order, 2014 Parish Of Ilminster

A letter had been received from the Planning Inspectorate giving details of how to submit information to the local inquiry regarding the Order to modify the definitive map by the addition of a footpath that starts at the northern end of the adopted section of Winterhay Lane and runs in a generally North North Easterly direction for approximately 480 metres.

167. Former Horlicks Site, Station Road, Ilminster

The Town Council discussed what is happening in relation to the marketing and the potential development of this site which is designated as employment land. Issues discussed during consideration of this agenda item included

Cllr Goodall had asked the Senior Planning Officer for any further information that was available as a result of the site meeting reported to the Town Council on 17 November 2015

Cllr Goodall then read out information provided by the Senior Planning officer which in summary said:

- that the site is not appropriate for housing and is not identified for such use in the Local Plan ,
- the site is not coming forward for employment purposes due to viability issues -
- the current owners, Dairy Crest, have said will bring forward plans for employment use if the relevant Councils and the community are willing to also accept up to 100 dwellings.

Issues discussed during consideration of this agenda item included:

- When first planning application was considered there was a housing element included
- The possibility of a compensatory reduction in the number of houses built on other sites
- The importance of the land as employment land
- The need and cost of the flood defences that will be required

RESOLVED that if a further site meeting is held and the Town Council is invited to send a representative(s) the latter should be from the following: the Mayor, the Chair of Planning, Cllr Shepherd and Cllr Fagan

168. Winterhay Lane Play Area - Award Offer From South Somerset District Council

- Initial discussion with South Somerset District Council regarding nomination criteria has resulted in advice that for consideration to be given to including land on the Community Right To Bid Asset Register the application must clearly demonstrate the existing community use and explain the proposed community use
- It would be possible for joint Community Right To Bid applications to be submitted
- No further information has been received about the Somerset County Council procedure for land disposal.
