- a) **22/03147/LBC** - 1 and 1A New Road - External and internal alterations to include repair of the portico and external render, replace the cement-based render and plaster with lime across the ground floor. Replace deteriorated interior joinery. To refit kitchens and bathrooms. To replace the consumer unit at the ground floor flat and to redecorate.
- b) **22/03056/HOU** - The Annexe 21-23 West Street - To add a second storey to the existing single storey building.
- c) **22/03117/HOU** - The Old Coach House 35A East Street - Installation of block wall in render, raised patio/terrace in blockwork with flagstone finish and timber fence in the raised garden to the rear of the dwellinghouse. Erection of timber framed pergola and two small timber sheds also in rear garden (Retrospective Application)

Amended plans have been received to alter the design/structure of timber fence in the rear garden.

- d) **22/03555/TPO** - Abbots Court, Court Barton - To carry out Tree Surgery Works to No. 1 Tree as shown within the South Somerset District Council (ILMI 1) 1989 Tree Preservation Order.

For your information, an application to undertake works to a protected tree or trees has been received.
