OS360 Minutes

OS361 Open Spaces report

Members **NOTED** the reports from the Grounds Manager and the Countryside Team. Members commented on how useful the new handrail on the steep section of Herne Hill will be, especially during the winter months. There are plans to look at the worn steps in due course.

Members discussed the volunteer who lives near the Burma Star Garden who tends to the garden and that the Town Council should look to write to formally thank her for all her hard work keeping the area looking at its best.

Members discussed the use of the tennis courts.

OS362 Financial Monitoring Report

Members **NOTED** the Finance Report.

Members were advised that we may need to look to buy a new noticeboard for the cemetery if the grounds team are unable to repair the current board.

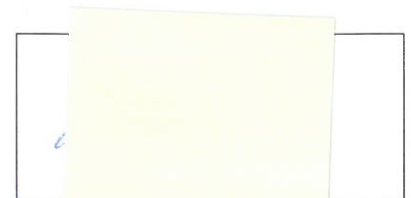
OS363 Welcome Back Funding

Members **NOTED** the report.

Members discussed the Welcome Back Funding and were advised that clarification has been sought and if an item was not on the original list, as long as it fits the criteria, it can be added.

Members discussed solar low level lighting in the Swan Precinct as the area is dark in the evenings and solar lighting is very low maintenance.

A member of the public has requested replacement bins in the town centre as the current bins need replacing and the Welcome Back funding can be used to purchase them.



Members discussed recycled benches like other local Town Councils have been using. They are environmentally friendly, they require little maintenance, they are easy to wipe down/keep clean and there is a space for a plaque. Members **RESOLVED** unanimously to recommend to Full Council to progress projects as identified at the Open Spaces meeting. Delegation to be given to Officers, the Chair and Vice Chair to implement the selected projects.

OS364 Permission for a Plaque under a tree in the Cemetery

Members discussed a request to place a plaque under a tree in Section D of the Cemetery.

Discussions included the type of plaque, whether it would hinder grass cutting and maintenance.

Members **RESOLVED** unanimously to **Recommend** that permission be granted, in consultation with Officers, to place a flat plaque/stone under a tree in section D of the Cemetery.

OS365 Permission for a plaque on a bench overlooking Britten's field

Members discussed the location, the wording on the plaque and the schedule of fees and charges.

Members **RESOLVED** by 5 votes for and 1 against to grant permission to place a plaque on a bench overlooking Britten's Field with the family making a donation towards the rejuvenation of the bench.

OS367 Recreation Ground Play Park

Members discussed the health and safety issue of children being able to crawl under the Sophie Louise.

Members **RESOLVED** unanimously to **Recommend** to Full Council to implement the installation of gravel boards to the legs of the Sophie Louise to be fitted by Play UK

OS368 Headstone Testing on the Cemetery

Members **NOTED** the headstone safety testing report.

Members discussed the cost of repairing the headstones and the likelihood of being able to contact family members due to the headstones dating back to 1846

Members **RESOLVED** unanimously to recommend that Town Council covers the cost of re sticking 12 headstones.

OS369 Ilminster Officers Cemetery Training – ICCM

Members **NOTED** that the office will review and update the policies and forms for the Cemetery and present back to the committee for agreement.

Members **NOTED** that the cemetery working group need to meet and share further information gained from the course and procedures that could be implemented.

OS370 Electricity and water supply on the recreation ground.

Members discussed adding an external tap and adding the required pipework for a sink and a water meter inside the tuck shop plus external and additional electrical sockets where required for the tuck shop and an external socket at the Warden's Buildings. Members have requested that we use local plumbers/electricians where possible.

Members **RESOLVED** unanimously to **recommend** to Full Council that officers arrange the installation of an external tap with a lockable cover and pipework for a sink in the Tuck Shop and add a water meter.

Members **RESOLVED** unanimously to Full council that officers arrange the fitting of external electrical sockets with lockable covers on the Public Toilet Block and Wardens Buildings, and to move internal sockets and install sockets where required in the Tuck Shop.
