Speaker 1

Tom Vaughan on behalf of Ilminster Youth Football Club Mr Vaughan thanked the Chair for the invitation to speak at the meeting. He updated members that they, ITYFC are looking to work with Ilminster Town Council towards a medium to long term lease which will allow them to apply for external funding and working together would be of mutual benefit. They support the Neighbourhood Plan, particularly the carbon neutral proposals. They are a not-for-profit organisation and they apply for funding from the Football Foundation.

Speaker 2

Tim England on behalf of Ilminster Town Youth Football Club Mr England advised members that he grew up in the local area and moved away. When he returned to the area he realised that the local football set up was excellent. They would like to work closely with the Open Spaces committee and may have previously benefited from working together. They appreciated the suggestion of pitches at the Winterhay Park but the current space is not big enough, there are no toilets/changing facilities and there is no or limited car parking. It would be an administrative burden to advise officers of all matches in advance. Cup matches are released during the week so there is not enough time to give 10 days' notice, as requested.

Mr England suggested setting up a working group.

# Speaker 3

Dan Haines spoke on behalf of Ilminster Town FC Senior team Mr Haines thanked the Chair for the opportunity to speak. He advised members that the club were blindsided by the proposed conditions that have recently been sent to them and they would like a better understanding of where the conditions came from. The 3 sports clubs work well together and any issues are addressed. They are keen to work together on any issues but felt that some of the conditions are not appropriate.

## Speaker 4

Sian Sainsbury on behalf of Ilminster Cricket Club Ms Sainsbury advised members that open spaces should be shared spaces. The Cricket club are looking to refurbish their bar facilities and in order to obtain any grants they would need to have a long term lease in place.
