#### **2022-0181-TC Neighbourhood Plan**

Members discussed the progress of the Neighbourhood Plan. The amendments that have been made are not policy changes, they are correcting spelling, punctuation and grammar errors.

Three people have been proof reading and checking the plan for the last few weeks.

A meeting is planned for January to look at the PR side and how to encourage residents to vote in the referendum.

Examples given to members are below,

- Figure 3 pg 40/41:
  - Add ILM3: The Ilminster Green Corridor (it's the hashed orange line already on Fig 6. We discovered yesterday during 9-hour amendments meeting that it refers to this map throughout the INP and we don't have it on Figure 3)
  - Add above to legend under ILM3: Blue Spaces (this keeps that whole policy together then)
  - Set 'Legend INP Identification' to the same to the same font size as all other maps (continuity)
  - Size all red hashed circles – Gateways and Key Road Junctions to the same size. I don't know why they are varying sizes. (We like the size of the one that is on pg41 set the lowest on the page)
- Figure 4a pg 50/51
  - Could we move Pin 1 slightly to the left. It is sat in the centre fold of the INP which makes it difficult to see
  - Add Pin 13 – Walking and Cycling Route. This will require a green hatched box to be added to the map. Please see attached to placement
- Figure 5 pg 84/85
  - Delete Potential Gateways and replace with: Gateways and Key Road Junctions
  - Size all red hashed circles – Gateways and Key Road Junctions to the same size. I don't know why they are varying sizes. (We like the size of the one that is on pg41 set the lowest on the page)
- Figure 6 pg 92/93
  - Add an \* after See South Somerset District Councils' 'Plan 4 - Value and Constraints' Ilminster Map for reference [Peripheral Landscape Study Ilminster Amended] and move it to under the legend as per Figure 3 and 4a for continuity

These are the changes to the main INP. There will be additional changes in the appendices to bring them into line with the bulk INP document
