P507 Public Forum

Keith Reeves addressed members regarding parking restrictions on West Street. Comments included parking restrictions cause pressure on Brewery Lane and by the Crown pub. Mr Reeves has spoken to the businesses and residents in West Street and apart from 2 businesses, who have brought season tickets for the car park, they indicated they were in favour of the restrictions being removed. Residents in the area have received parking tickets as they thought it was free parking for residents.

There were no dispensations requested or granted.

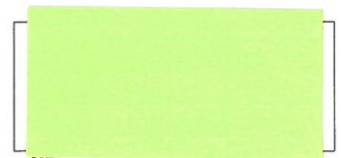
P511 Minutes

P512 West Street restricted parking

Members discussed the parking restrictions in West Street. Discussions included: would residents like the restrictions removed completely or for the area to be made residents/permit parking. If there had been any



feedback from the Chamber of trade. If parking restrictions are removed it would be open access for anyone to park there. Would the restrictions be removed from Silver Street to Brewery Lane or for a smaller area. There were concerns raised about the existing parking at the junction onto the main road as visibility can be difficult at times.

Members discussed that there would have to be a public consultation as part of the Traffic Regulation Order.

Members **RECOMMEND** to Full Council that officers be delegated authority to write to Somerset County Council to remove the West Street Traffic Regulation Order from Silver Street to Brewery Lane, taking into account any safety recommendations put forward by Somerset Highways.

Swan Precinct unlit at night

Members discussed the Swan Precinct being unlit at night. Discussions included the land is privately owned, who would pay for the maintenance and the electricity bill, the residents have concerns that any lighting may shine into their homes. If the area is lit, it may attract groups of people to frequent it. Even though it is a dark area there has been no recent trouble/vandalism. It can be intimidating for people walking through the precinct at night. Low level lighting at the base of the planters may be enough to make people feel safe. The precinct is not the only throughfare to and from the supermarket. Could some kind of lighting be put on the archway/wall owned by Tesco.

Members **RESOLVED** unanimously to recommend to Full Council that officers be delegated authority to contact Tesco Ilminster Store to establish what help can be given to light Swann Precinct.

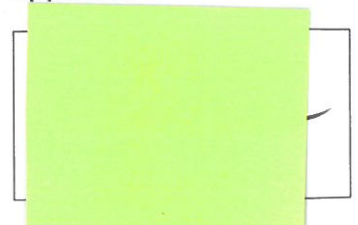
