Members discussed the Silver Street archway access.

Discussions included: the business needs 24 hour vehicular access to the rear of the building, the current H bar is not enforceable, residents were canvassed 2 years ago reference parking on Silver Street, and whether the school zig zag lines could be extended.

Members **RESOLVED** by 6 votes for and 1 against that officers will contact Highways to request that the yellow zig zag lines outside Greenfylde CofE Primary School are extended to cover the archway entrance.

#### 22-0016-PHT Church Lane/Path trees

Members discussed the overhanging trees along Church path. Discussions included: this has been an ongoing issue for the last 3 or 4 years, the overhanging branches are high up and do not compromise walking along the path, the legal position of cutting back overhanging trees, do the trees have tree preservation orders, the trees are in a conservation area, that it is a civil dispute and so it is outside of the Town Council's remit.
