# 2023-0223-TC Ilminster Town Council's 50th Birthday

# 2023-0224-TC Somerset Council Update

The Town Clerk provided an update from the Somerset Council Budget Meeting held earlier on this day. Somerset Council approved their budget, the Highways cuts had been postponed for 12 months, any planned reduction in services had been scaled back, £600K had been allocated for the transition to town/parish councils, however the funds remain with Somerset Council. Any legal costs would be picked up by town/parish councils. Somerset Council were looking at a 20% reduction in their workforce. Ilminster Town Council have been working with Crewkerne Town Council to find solutions, and it was the Town Clerk's opinion that the town/parish councils had been given a rough deal and treated badly by Somerset Council.

Further discussions included being aware of threats but seek out the opportunities that may arise. The legal fees associated with small parcels of land could be significant. The possibility of paying for a retained solicitor.

Members **RESOLVED** to delegate officers 9 votes for, 1 abstention (Cllr Osborne):

- a) To notify Somerset Council that ITC are extremely unhappy that city, town and parish councils are being asked to take over assets and services without financial support being provided to those for whom legal costs and due diligence costs are likely to be wholly disproportionate to their precept.
- b) To establish the areas for entering into SLA's for the maintenance of areas as opposed to taking over ownerships with SC. This to include verges, hedgerows and other green areas.
- c) To discuss the short-term arrangements for interim grass cutting and then the long term plans for land currently cut in Ilminster by Somerset Council.
- d) To negotiate future plans regarding what changes are to take place in respect of drains and pot gulley maintenance and clearance. To also establish frequency of street cleaning and level of service that will be carried out in the coming years.
- e) To establish what highways training will be available for Ilminster staff to enable them to take on the duties on behalf of Somerset Council.

- f) To vire £6,000 from the Earmarked Reserves allocated in the 2024/25 budget for the Tuckshop/toilets refurbishment to cover the cleaning of the Toilets outside Tesco. Officers then to establish the implications if the lease is transferred to the Town Council.
- g) To produce a report detailing the costs and implications of dog and street bin emptying over the next year following meetings with Somerset Council.
- h) To work with Somerset Council officers to establish the possible transfer of the two playgrounds at Greenfylde and Blackdown play parks. Details to then be brought back to Members for their consideration.
