## 157. Request to use the Wharf lane Recreation Ground

The Committee considered a request from an all human circus to use the Wharf lane Recreation Ground.

- The number and size of vehicles which the circus would wish to take onto the Rec
- The potential attendance
- What facilities the circus may require to be provided e.g. water, electricity

#### **RESOLVED**

- (ii) that the Town Clerk obtains information regarding potential facilities required and attendance
- (iii) that the Town Clerk contacts of two places the circus has been to in the past 12 months as reference sites
- (iv) that the Town Clerk reports the information obtained in (ii) and (iii) above to a future meeting of the Committee so that a decision can be made regarding charges.

## 158. Ground Conditions on the Wharf Lane Recreation Ground
