2) Concern about the practicality of room sizes/living space particularly in the affordable housing.

With reference comments 1. and 2. above the Town Council would like comments on the overall layout and living spaces to be sought from social housing providers.

3) The information provided with the application is out of date. Following recent flooding incidents new flood plans indicate that the site is at risk of flooding.

4) Concern about the effect the amount of building proposed will have on the existing infrastructure, particularly sewage and rainwater drainage.

- 5) The Town Council would like to see a small play area for pre-school children included in the proposal, preferably close to the affordable housing area. Councillors feel that the main recreation ground could be reached safely by older children but toddlers needed a safe play area closer to their homes.
- 6) Funding arrangements for the maintenance of the area designated as public open space needs to be clarified.
- 7) Clarity is required about responsibilities for shared surface streets.
- 8) The road network within the housing development only has a single entrance which is a concern for access for emergency vehicles.
- 9) The Social Housing has not been split up within the development as suggested previously by the District Council.
- 10) The meter boxes on the properties need to be designed and coloured to disguise as much as possible.

Administrative Note:

It was brought to the attention of the Town Clerk that a digger has been working on the above site. After further investigation it has been found that the contractors, CJL Construction, have been employed by the developers to start laying the concrete foundations for the site office, even though planning permission has not been granted. The Town Council are taking this matter further.

South Somerset Car Parking Strategy Review

Your members may recall that I wrote to the Town Council in August 2012 inviting comments in relation to the current off-street car park provision in the town. This work formed part of a selective review of the car parking strategy, which included a primary aim to ensure that off-street public parking provision enhances the vitality and viability of our market towns and rural centres.

I am writing to inform you that Full Council adopted the South Somerset Car Parking Strategy Review on Thursday 20th June and the revised strategy can be viewed on the SSDC website http://www.southsomerset.gov.uk/environment/travel/cars-and-parking/cars-and-parking/ (Please scroll down until you reach "District-wide car parking strategy").

The comments that your council helpfully provided have been used to inform this review and have been summarised in the Town by Town Action Plan on page 17. In respect of Ilminster these actions are shown as:

Key Issues	Action	When	Who	
Small surplus, although local concerns that CPE has increased on street parking.	Reassess future off-street parking provision in Ilminster should changes to residents' parking areas be introduced.	As & when residents parking comes forward	Town Council SSDC	&

The above action has been designated as a 'low priority' at this stage as this is dependent on residents' parking measures being introduced.

Whilst on-street parking is the responsibility of the County Council, Action PS22 in the adopted Strategy states "The Council will act in a supporting role with Town and Parish Councils in finding additional off-street spaces where there are proven resident parking problems leading to congestion and environmental issues". I am therefore enquiring if the Town Council would like this to be actively explored and I would be grateful if you could confirm whether this remains the position. That being the case I would suggest that you write to our Property & Engineering Services Manager, Garry Green, in order that we can move forward as soon as priorities and work programmes permit.

We also note the Town Council's comments in respect of the then recently introduced Civil Parking Enforcement (CPE). CPE and on-street parking provision, including the revision or introduction of Traffic Regulation Orders (TROs) necessary to control and manage on-street parking is very much a County Council responsibility as the Highway Authority. Should any of these matters still be an issue I would advise you to view the Somerset Parking Services webpage — www.somerset.gov.uk/parking. Under Related Services you will find advice on Traffic Regulation Orders. I would also draw your attention to Policy PS6 (page 21 in the Car Parking Strategy Review), which offers the District Council's engagement with the County Council in the review of TROs as and when the County Council review or at the request of Town & Parish Councils.

Similarly in relation to the enforcement of cars parking on double yellow lines, I would suggest, if this is still an issue, that you contact Somerset Parking Services on 0845 3371000 or somerset@parkingenquiry.co.uk
