**ROAD TRAFFIC REGULATION ACT 1984,
TEMPORARY ROAD CLOSURE
PUCKINGTON ROAD TO RUSKWAY LANE, BARRINGTON**

I am writing to inform you that Somerset County Council as the Highway Authority have received an application for the temporary closure of Puckington Road to Ruskway Lane from Atkins (on Behalf of Wessex Water).

This road will be closed from 01st September 2015 and is expected to last for 4 weeks to enable laying of new water main works to be carried out.

Please find enclosed a plan showing the length of the closure in RED and the alternative route in GREEN.

Every effort will be made to keep the duration of this closure to a minimum to reduce any further disruption.

Temporary Closure of Puckington Road to Ruskway Lane

TAKE NOTICE that in pursuance of Section 14(1) of the Road Traffic Regulations Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the County Council of Somerset propose to make an Order **PROHIBITING ALL TRAFFIC** from proceeding along **Puckington Road to Ruskway Lane** from the **junction with Main Street northwards** for a distance of **300 metres**.

This order will enable Atkins (on Behalf of Wessex Water) to carry out laying of new water main in this road.

The Order becomes effective on **01 September 2015** and will remain in force for eighteen months. The works are expected to last for **4 weeks**. While the closure is in operation an alternative route will be signed as detailed below.

ALTERNATIVE ROUTE

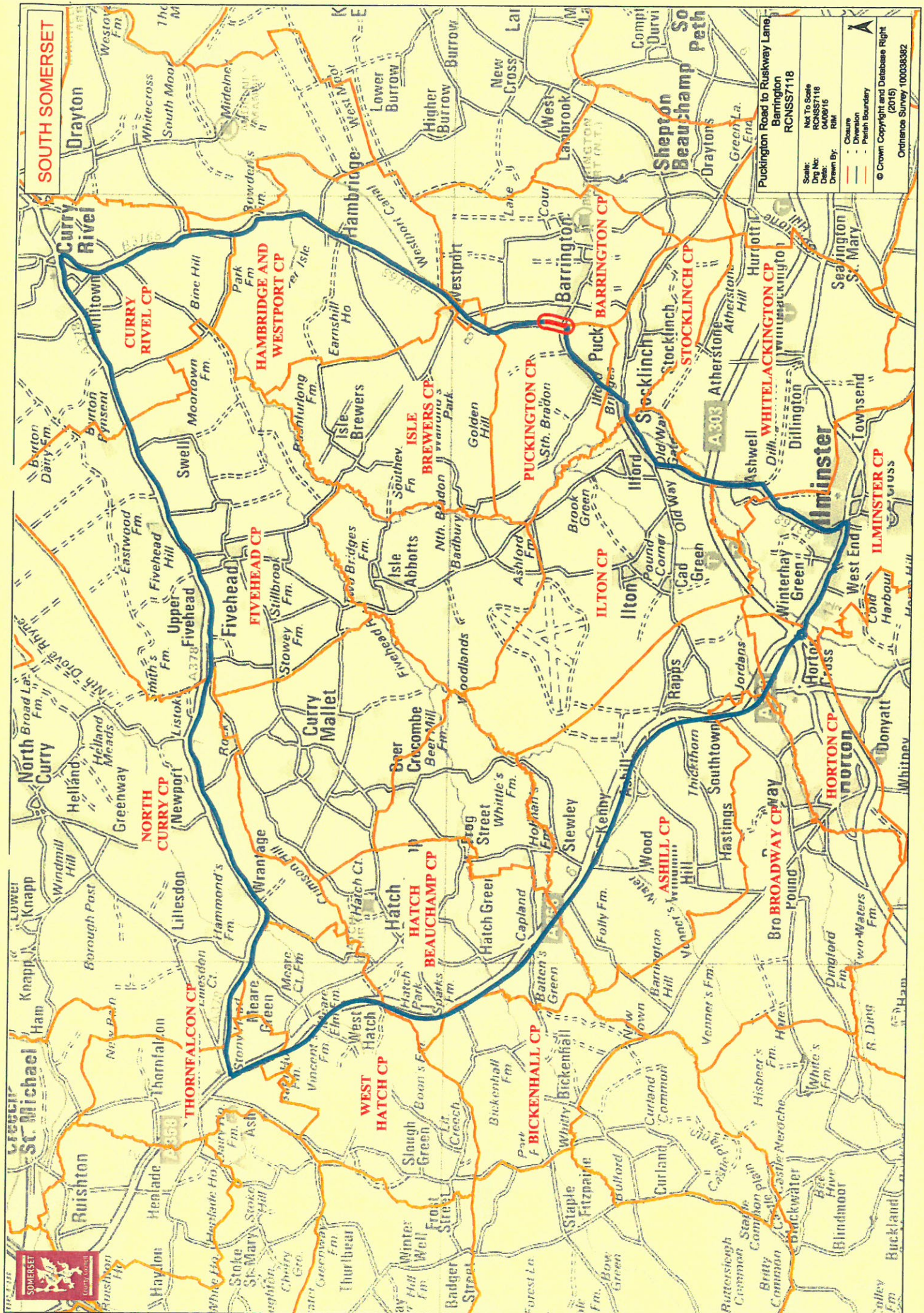
From the southern end of the closure proceed in south westerly and north westerly directions along the B3168 and the A358 to the junction with the A378. Turn right and proceed in north easterly direction along the A378 to the junction with the B3168. Turn right and proceed in south easterly and south westerly directions along the B3168 to the northern end of the closure, and vice versa.

TAKE NOTICE that in pursuance of Section 14(1) of the Road Traffic Regulations Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the County Council of Somerset propose to make an Order **PROHIBITING ALL TRAFFIC** from proceeding along **Ditton Street** from **junction with Silver Street, Southwards** for a distance of **125 metres**.

This order will enable Wales and West Utilities Ltd to carry out new gas supply works in this road.

The Order becomes effective on **08 September 2015** and will remain in force for eighteen months. The works are expected to last for **4 days**. While the closure is in operation an alternative route will be signed as detailed below.

ALTERNATIVE ROUTE

From the northern end of the closure proceed in a north westerly direction along Silver Street, West Street and Station Road to the junction with Rec-Sur-Belon Way. Turn left and proceed in a south westerly direction along Rec-Sur-Belon Way to the junction with Canal Way. Turn left and proceed in south easterly and north easterly directions along Canal Way and Orchard View to the junction with Ditton Street. Turn left and proceed in a north easterly direction along Ditton Street to the southern end of the closure.
