Speaker 1

At the request of a member of the public, who was attending the meeting, the Mayor read out a letter which the member of the public had sent to the Town Council: itl contained the following text: 'Ilminster's initial approach to S.C.C Highways on 20 November via Mrs L Vijeh has been met with the comment "not enforceable." 'Accordingly to the Somerset County Gazette on 6 November 2014 Wellington's request for 20 mph zones in Wellington will be considered by S.C.C. How will the Council deal with this'?

The Chair informed the speaker that the Town Council would respond formally to his letter.

Speaker 2 a Cricket Club representative wished to thank the Council for considering the Cricket Club's request. He informed the Council, following Planning Permission being granted for improvements to the pavilion, the Cricket Club is now seeking help to fund the project, and wished to ask the Council for its support by making a recommendation to South Somerset District Council for the allocation \$106 monies.

304. Mayor's Announcements/Engagements

a) The Deputy Mayor made the following announcement relevant to Town Council and Mayoral activities and engagements.

It had been a quiet month with few engagements to attend, however the Mayor enjoyed this year's Remembrance Day Service at the Minster Church on Sunday 9th November 2014.

305. Police Report

The Ilminster Beat Report for November 2014 was circulated prior to the meeting.

306. Reports from District Councillors

Councillor Goodall circulated a written report prior to the meeting and the following points were highlighted:

- Victorian Evening and the arrangements for litter collection
- Victorian Evening and the availability of public toilets
- Somerset Waste Partnership and the collection of additional materials which now include plastic trays, tubs, electrical equipment and batteries

307. Report from County Councillor for Ilminster

County Councillor Vijeh submitted a written report for October 2014 which was circulated with the agenda.

Issues discussed included:

- Winterhay Lane status of the footpath order
- Interim Director appointed for Children's Services, Somerset County Council now advertising for a permanent member of staff
- Concern about the shortfall of social workers in Somerset
- Street Lighting not working in Ilminster including The Beacon, Eames Orchard, Black down View
- The work to drainage system recently carried out seems to have helped, although Ditton Street recently flooded, Councillor Shearman noted that there has been no movement regarding Somerset County Council Highways drainage maintenance in Ilminster, as published in Chard & Ilminster News on 17th October 2014.

308. Reports from Representatives on Outside Bodies

The Council received a report from the following Representative on an outside body:

Youth Club - Councillor Burton informed the Council that the Youth Club had been experiencing staffing issues but is glad to report that it is now addressed and changes have been made to the organisation structure; this will enable volunteers to have the opportunity at working towards an NVQ qualification through Somerset County Council sponsorship. Councillor Burton reported that he had recently visited a youth club in Somerton which he found very useful, allowing him to look at how other youth clubs run. Councillor Burton further reported that the Youth Club are actively seeking funding for projects so will probably submit a grant application to Council. As always, Councillor Burton

encouraged Councillors to attend the Youth Club. Councillor Burton notified the Council of the following dates:

Youth Club have arranged a Santa's Grotto to be held on Victorian Evening Friday 21st November 2014.

309. Open Spaces Recommendation

The Council considered the recommendation from the Open spaces committee meeting held on 28th October 2014. A report was circulated to council regarding Trimax Grass Cutting equipment for Council's consideration.

Issues discussed included:

Suitability for use at the Cemetery and other Open Spaces

RESOLVED that

- i. That the Trimax 'Snake' mower is purchased at a cost of £14,600 subject to supplier providing satisfactory references.
- ii. That the best possible price is obtained for the disposal of the current gang mowers (whether by part exchange or private sale).
- iii. That the purchase of the Trimax mower is funded as follows:
 - £12175 from Earmarked Reserves for Gang Mower replacement.
 - £1200 from the current budget for servicing the gang mowers this winter
 - £1500 estimated part exchange

310. Allocation of \$106 monies

The Town Clerk reported the request received from the Cricket Club for the allocation of S106 monies for sport and pitches and circulated the criteria agreed by the Town Council at a previous meeting on 22nd July 2014 for Councillors to cross reference.

NB: Council went out of Session at 20:20hrs to ask the Cricket Club representatives for more information and resumed at 20:30 hrs.

Issues discussed included:

- Feasibility of the project without grant funding
- Possible funding sources for the project
- Suggestions of appropriate consultation methods, including putting a notice on the Town Council Notice Board
- The number of people that will benefit from the project

RESOLVED that

- (i) the Cricket Club should submit a grant application to Town Council
- (ii) that additional information is required to meet the Town Council's criteria for submitting a request for s106 money e.g. public consultation
